South County Connector Public Meeting May 30 In Shrewsbury

May 24, 2013

The St. Louis County Department of Highways and Traffic will hold a public hearing for the South County Connector Draft EIS on Thursday, May 30, 4 to 8 p.m., at Shrewsbury City Center, 5200 Shrewsbury Ave.



The purpose of the hearing is to provide an opportunity for all interested people to give testimony concerning the Draft EIS, including potential social, economic and environmental impacts, both positive and negative, of the proposed alternatives as described in the recently released Draft EIS.

Representatives of the South County Connector Study Team will also be available to provide information and answer questions about the Draft EIS at an open house meeting held at the same time as the public hearing. No formal presentation will be made. Display boards and copies of the Draft EIS will be available for review at the open house meeting.

Verbal and written comments on the Draft EIS will be accepted at the public hearing. A court reporter will document verbal comments and forms for written comments will be provided.
